WHEREAS, the Board of Trustees has received notice of a recent incident in which a political candidate was invited to speak at a meeting of the Friends of the Williamson Public Library, which was inconsistent with Library policy; and

WHEREAS, the Board wishes to ensure public confidence in the Library's neutrality, protect the Library's legal and ethical standing, and provide clear guidance to affiliated organizations;

NOW, THEREFORE, BE IT RESOLVED that the Williamson Public Library Board of Trustees affirms that the Library does not endorse or permit political campaigning or electioneering in Library facilities, regardless of the sponsoring group or organization; and

BE IT FURTHER RESOLVED that all organizations, including affiliate groups such as the Friends of the Williamson Public Library, must complete and maintain Meeting Room Booking Slips on file for all meetings and events conducted in Library space; and

BE IT FURTHER RESOLVED that the Board will communicate this policy clarification to the Friends and to ensure consistent implementation going forward."
